

**TOWN OF DOUBLE OAK
MUNICIPAL COURT
INSTRUCTIONS FOR COMPLETING A DRIVER'S SAFETY COURSE**

1. You must have a valid Texas Drivers License or Permit.
2. You must not have been charged with violating the posted speed limit in excess of 25 mph.
3. You may only take a driver's safety course once a year for dismissal of a ticket. This will be reflected on your driver's record.
4. You must enter a plea of guilty or nolo contendere before your court date/time.
5. You must present to the court in person, a written request to take the driving safety course.
6. You must file an affidavit with the court stating that you are not in the process of taking a course under section 143A (a) (2) of the Uniform Act and that you have not completed a course under this subdivision that is not yet reflected on your driving record.
7. You must pay **\$107.00** for Administration and State Fees to the Town of Double Oak Municipal Court. If your citation was issued within a designated school zone, the fee will be **\$132.00**. If requested after appearance date, the fee is **\$157.00 (\$182.00 School Zone)**. This fee must be paid at the time that you request the course.

You must submit a **CERTIFIED COPY OF YOUR DRIVING RECORD TO THE COURT WITHIN 90 DAYS OF THE DATE YOU REQUEST PERMISSION TO TAKE A DRIVER'S SAFETY COURSE.** You may request your driving record at the following website: <https://www.texasonline.state.tx.us/tolapp/txldr cdr/TXDPSLicenseeManager> . Request a **type 3A** driving record, the cost is **\$12.00**. **The court will only accept a certified driving record from the Department of Public Safety.**

8. It is your responsibility to make arrangements to take the driver's safety course. You may take the course through any agency that is approved by the State of Texas. **Failure to complete the driver's safety course and return the required forms will result in the termination of your right to take the course.** Should this happen, you will be responsible for paying the fine in full and the offense will be reported as a conviction on your driving record. You must complete your course and turn the paperwork in no later than 90 days from the date of your request.
9. No extensions will be granted.
